Marika Kovacs-Houlihan, M.Ed., is a professor of American Sign Language (ASL) and Coordinator for the ASL Studies Program at the University of Wisconsin, Milwaukee. Marika received a Bachelor of Arts Degree in Marketing from Rochester Institute of Technology in New York, and a Master's degree in Adult Education and Leadership from the University of Wisconsin-Milwaukee.

Her valuable attributes are her theatrical experiences and her passion in ASL Literature. Her master's research topic was ASL Cinematic and how to use this as a teaching tool. She has numerous presentations related to ASL Cinematic and Depiction to local and national conferences, also co-presented with colleagues on ASL Programs/Curriculums in the post-secondary level. Marika published her chapter in *Deaf Eyes on Interpreting* in 2018 titled "The Ingredients Necessary to Become a Favorite Interpreter". She is fourth generation member of a Deaf family. She and her husband, Dan, has been actively promoting a positive identity for their four KODA children: Zane, Riley, Ainsley, and Caden.

This workshop will give an overview of visualization, depiction, and the different types of depiction as they are used in ASL.

Depiction allows a visual representation of semantic components that are essential in American Sign Language (ASL).

Participants will view, identify and analyze at least three examples of Depiction using videos provided by presenter. They will demonstrate the rules and use of depiction tools by identifying and outlining five examples in small groups, and participants will practice interpreting (visually representing) three examples of depiction using ASL.

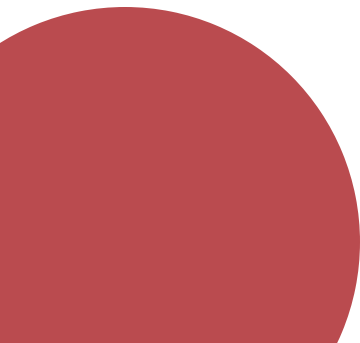
Non-discrimination Policy:
